



Dear Village Club Member:

It's time to specify your membership for the **2018** season!

Types of Memberships*: (only the family memberships include children)

Capital Improvement Fee** – Each membership is assessed a fee for improvements to the club. For 2018, the fee is \$50 for regular memberships and \$40 for senior memberships. This fee is paid along with the dues payment.

PLEASE CIRCLE THE APPROPRIATE MEMBERSHIP TYPE FOR YOU

Senior Single – A person 55 years of age or older. **\$400 + \$40 = \$440.00**

Single – A person 18 years of age** or older. **\$500 + \$50 = \$550.00**

Senior Couple – A person and their spouse or partner with a combined age of 110, who reside together at the same address. **\$600 + \$40 = \$640.00**

Couple – An adult and their spouse or partner with a combined age less than 110 who reside together at the same address. **\$700 + \$50 = \$750.00**

Single Parent Family – An adult plus their childless, unmarried children under the age of 25, who reside together in the same household. **\$800 + \$50 = \$850.00**

Family – A person and their spouse or partner plus their childless, unmarried children, under the age of 25, who reside together. **\$900 + \$50 = \$950.00**

Plan A Pay in full by Feb 1st, 2018 the appropriate amount underlined above***.

Plan B 3 payments: Feb.1st, Mar.1st and Apr.1st (includes \$15 processing fee).

Senior Couple: \$220, \$220, \$215

Couple: \$255, \$255, \$255

Single Parent Family: \$295, \$285, \$285

Family: \$325, \$320, \$320

** Memberships do not include grandchildren, nieces, nephews, cousins, aunts, uncles, and grandparents, children temporarily assigned to the home or friends of the family. A family membership may include a foreign exchange student in the household or children for whom the member has legal guardianship with approval.*

June 1st is the cut-off date to determine age for each type of membership.
