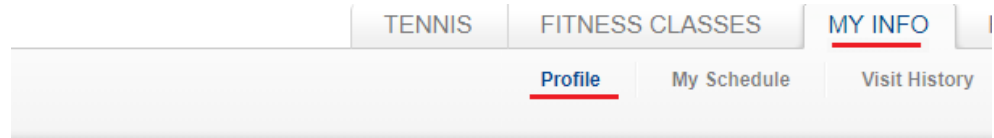

I voluntarily agree to assume all of the foregoing risks and accept sole responsibility for any injury to my family or myself (including, but not limited to, personal injury, disability, and death), illness, damage, loss, claim, liability or expense, of any kind, that I or my family may experience or incur in connection with my family's attendance at the VC or participation in VC leagues, classes or activities ("Claims"). On my behalf, and/or on behalf of my family, I hereby release, waive, relinquish, discharge, and hold harmless the VC, its employees, agents, and representatives, of and from the Claims, including all liabilities, claims, actions, damages, costs or expenses of any kind arising out of or relating thereto. I understand and agree that this release includes any Claims based on the actions, omissions, or negligence of the VC, its employees, agents, and representatives, whether a COVID-19 infection occurs before, during, or after participation in any VC attendance. On behalf of myself and my family, I have read and understand the terms of this Waiver and Release of Liability Agreement and agree to its terms.'
