



Waiver and Release of Liability By Village Club Members

The novel coronavirus, COVID-19, has been declared a worldwide pandemic by the World Health Organization. COVID-19 is extremely contagious and is believed to spread mainly from person-to-person contact. As a result, federal, state, and local governments and federal and state health agencies recommend social distancing with the congregation of groups of people.

The Village Club (“VC”) has put in place preventative measures to reduce the spread of COVID-19; however, the Club cannot guarantee that members and/or their families will not become infected with COVID-19.

By signing this agreement, I knowingly and voluntarily, assume all such risks, both known and unknown, relating to my and/or my family’s risk to be exposed to or infected by COVID-19 by attending the VC and that such exposure or infection may result in personal injury, illness, permanent disability, and death. I understand that the risk of becoming exposed to or infected by COVID-19 at the VC may result from the actions, omissions, or negligence of my family and others, including, but not limited to, VC employees, volunteers, and VC Members.

I voluntarily agree to assume all of the foregoing risks and accept sole responsibility for any injury to my family or myself (including, but not limited to, personal injury, disability, and death), illness, damage, loss, claim, liability, or expense, of any kind, that I or my family may experience or incur in connection with my family’s attendance at the VC or participation in VC leagues, classes or activities (“Claims”). On my behalf, and/or on behalf of my family, I hereby release, waive, relinquish, discharge, and hold harmless the VC, its employees, agents, and representatives, of and from the Claims, including all liabilities, claims, actions, damages, costs or expenses of any kind arising out of or relating thereto. I understand and agree that this release includes any Claims based on the actions, omissions, or negligence of the VC, its employees, agents, and representatives, whether a COVID-19 infection occurs before, during, or after participation in any VC attendance.

Club Changes for Summer of 2020

- No Guests will be allowed to enter the VC. The VC Board will re-assess this rule to possibly allow guests starting July 1st.
- All Staff Workers will perform a self-assessment before coming to work and will have their temperature taken before login each shift.
- Check-In
 - There will be ground markings near the window to encourage social distancing while waiting to check in.
- Tables and Chaises.
 - Tables may not be moved.
 - Laminate e Cards will be used for easy determination of table and chaise status (in use, cleaned, needs cleaning).
 - Members are encouraged to bring their own tablecloths.
 - Staff will clean and sanitize/disinfect tables/chairs/chaises when a member is finished using them.
- Staff will be cleaning and disinfecting high touch areas on a regular basis throughout the day.
- Locker Rooms
 - Showers will have capacity limits.
 - Locker rooms will be cleaned and disinfected on a regular basis throughout the day with deep cleaning and disinfecting at least once a day.
- Concessions
 - ONLY pre-packaged food and bottled drinks will be sold with the exception of Slushies.
 - There will be ground markings near the window to encourage social distancing while waiting your turn.
 - All concessions must be paid for with funds already on your VC key tag. No cash. No exceptions.
 - Members to bring their own utensils, plates, cups, napkins, condiments & grill tools. The VC will not provide these items this year.
- The VC will not have any Social Events this Summer. The July 4th distribution of free beverages will continue.
- Ping Pong Tables will not be available.



- POP Tennis Racquets will not be available for check out.
- Pickleball Paddles and Balls will not be available for check out (courts are still available with members own equipment).
- Outside of Pool Social Distancing is expected.
- There will be ground markings near the diving board to encourage social distancing while waiting your turn.
- Lap Lanes will be offered from 9-11am for the month of June. The VC Board will re-assess this for the remainder of the Summer.
- Aquatic Lessons – There will be NO Lessons for the month of June. The VC Board will re-access this for the remainder of the Summer.
- Tennis
 - Modified Leagues and Lessons per updated packet.
 - Junior Lessons and State League for children 8 years of age and older.
 - NO Benches, Chairs, Bleachers or Score Cards on courts. Water Coolers will not be furnished by the Club on the courts this summer.
